- 4. In case the vehicle is not as per specification, the same shall be replaced by the vendor/supplier. High Commission will not be responsible for any theft or loss at any stage before handing over of the consignment at the delivery address.
- 5. The supply of above mentioned vehicles should be commenced immediately from the date of issue of work order and must be completed within stipulated time (**30 days**) from the date of receipt of work order.
- 6. No compromise will be accepted in respect of quality and specification of the above mentioned vehicles.
